Annex No. 5 to Resolution No. 2538 of the Senate of Wroclaw Medical University of 28 June 2023

Application conditions and procedure for the first year of full-time long-cycle Master's degree studies conducted in English at the Wroclaw Medical University for candidates in the academic year 2024/2025 at:

- 1. Faculty of Medicine,
- 2. Faculty of Dentistry.

Art. 1

Pursuant to Article 79 and Article 323 of the Act of 20 July 2018 Law on Higher Education and Science (consolidated text: Dz.U. /Journal of Laws/ of 2023, item 742, as amended), the application conditions and procedure for the full-time long-cycle Master's degree studies in English are hereby established for the academic year 2024/2025 at the following faculties: medicine, dentistry.

Art. 2

General provisions

- 1. The application for admission to full-time long-cycle Master's degree studies shall be based on:
 - a certificate of secondary education or a certificate of secondary education and a certificate of the matura exam in certain subjects referred to in the Act on the Educational System;
 - a certificate of secondary education and a diploma confirming vocational qualifications in a profession taught at the level of a technician, as referred to in the Act on the Educational System;
 - a certificate of secondary education and a vocational diploma in a profession taught at the level of a technician, as referred to in the Act on the Educational System;
 - a certificate of secondary education and a certificate of the matura exam in certain subjects and a diploma confirming vocational qualifications in a profession taught at the level of a technician, as referred to in the Act on the Educational System;
 - a certificate of secondary education and a certificate of the matura exam in certain subjects and a vocational diploma in a profession taught at the level of a technician, as referred to in the Act on the Educational System;
 - 6) certificate and other document issued abroad by a school or educational institution recognised by the state on whose territory or in whose educational system it operates, approved by means of an administrative decision as a document confirming secondary education or entitlement to apply for admission to higher education in the Republic of Poland, taking into account the scope of entitlements in the state in which the certificate or other document was issued (under Article 93(3) of the Education System Act, Dz.U /Journal of Laws/ of 2022, item 2230);
 - 7) a certificate and other document issued by a school or educational institution operating in the educational system of a Member State of the European Union, a Member State of the

Organisation for Economic Co-operation and Development (OECD), a Member State of the European Free Trade Association (EFTA) – a Party to the Agreement on the European Economic Area, entitling one to apply for admission to higher education in these countries (under Art. 93(1)(1) of the Act referred to in item 6);

- 8) the International Baccalaureate (IB) diploma issued by the International Baccalaureate Organization in Geneva and the European Baccalaureate (EB) diploma issued by European Schools in accordance with the Convention defining the Statute of the European Schools drawn up in Luxembourg on 21 June 1994 [Dz. U. /Journal of Laws/ of 2005, item 10; under Article 93(1)(2) and (3) of the Act referred to in item 6];
- a certificate or diploma recognised in the Republic of Poland as a document that entitles its holder to apply for admission to higher education studies under the bilateral agreement on mutual recognition of education;
- 10) a certificate or other document recognised as equivalent to the Polish certificate of secondary education under the provisions effective until 31 March 2015
- hereinafter referred to as "graduation certificate".
- 2. Candidates with a valid national identification card or a Polish passport (evidence of Polish citizenship) and, at the same time, a passport of another country shall be considered Polish citizens by law.
- 3. The number of places for each field of study is limited and is specified in the Senate's resolution on the limits of admissions to the first year of study for a given academic year.
- 4. The admission of candidates to the first year of studies is based on the fulfilment of application conditions, specified in this document.
- 5. The University's website provides recruitment information, particularly on:
 - 1) application conditions for the first year of studies in the academic year 2024/2025,
 - 2) application schedules for 2024/2025, separate for each field of study, hereinafter referred to as "schedules",
 - 3) link to the Online Application System for Candidates, hereinafter referred to as "IRK",
 - 4) lists of candidates (Conditionally Accepted, Accepted),
 - 5) application information and current announcements.
- 6. The application procedure shall include:
 - 1) complete registration in the IRK,
 - timely payment of the full fee for conducting the application procedure, hereinafter referred to as the "application fee", to the University's bank account, individual for each candidate, field and mode of study, generated in the IRK,
 - 3) admission procedure conducted by the Admission Board, hereinafter referred to as "AB",
 - verification of candidates' documents by the AB and determination of the list of candidates for admission by the Rector,
 - 5) submission of required documents to the AB by the candidate or a proxy of the candidate who has been selected for admission to the university,
 - 6) enrolment of the candidate on the list of students and in the case of foreigners taking and issuing of the Rector's administrative decision on admission to studies,
 - 7) timely completion by an admitted student of formalities that are necessary for enrolment into the first year of study.

7. Deadlines and activities related to the application process, which are separate for each field and mode of study, are included in appropriate schedules.

Art. 3

Admission procedure

The admission procedure will be open to the candidates who do the following within the period outlined in the schedule:

- register in the IRK, i.e.: correctly and fully fill in the compulsory fields in the candidate profile, including the choice of the field of study, and attach a legible file (max. up to 100 KB) with a recent colour photograph of 300 x 375 pixels in JPEG-JPG format, at a resolution of no less than 300 DPI (corresponding to a 35x45 mm photograph) taken in accordance with the requirements for the issue of national identity cards in Poland,
- pay the full amount of the application fee to the University's bank account, individual for each candidate and generated in the IRK. A payment made to other bank accounts of the University will not be taken into consideration (it is tantamount to the absence of payment),
- 3. attach legible scans (in PDF or JPEG format) of the required documents referred to in Art. 7 in the IRK.

Art. 4

Rules for converting results stated in graduation certificates

- 1. The **basic** criterion for the admission procedure is:
 - the results on the graduation certificates referred to in Art. 2(1), in the subjects called "major subjects" referred to in Table 1:

2) English proficiency certificate (not applicable to candidates with a graduation certificate

issued in countries where the official language and language of instruction is English, i.e.: the USA, Canada, the United Kingdom of Great Britain and Northern Ireland, Australia, New Zealand and candidates with a diploma issued by a school where the curriculum was taught in English (applies to IB Diploma and EB Diploma, among others) – in the absence of information on the language of instruction on the diploma, an attestation indicating the language of instruction at the school is required.

For graduation certificates issued in:

a) countries of the EU, EFTA, Swiss Confederation:

a language certificate is required from the applicant, or a grade in English from the certificate of secondary education (according to Table 13) or other certificate of language skills at least at B2 level according to the CEFR (Common European Framework of Reference for Languages),

b) countries other than those of the EU, EFTA, Swiss Confederation:

- a candidate shall provide an appropriate document from the list included in Table 12.
- 2. The rules for converting results stated in graduation certificates into points (applies to both Polish and foreign graduation certificates):
 - result/score the grade obtained in the major subject is to be converted into application points according to the rules specified in Table 1;
 - 2) the minimum number of points for a candidate to be eligible for the admission procedure is **100 points in total from two major subjects,** provided that the result from none of them is lower than 30 points. Candidates who have not fulfilled the conditions described in this section will not be considered for the application process.
- 3. Candidates who have obtained their **certificate of secondary education from the "new" matura exam** applicable in Poland since 2005 will be admitted based on their results from the matura exam in the major subjects referred to in Table 1, with the proviso that in the case of the bilingual matura exam, only the result obtained in the subject passed in Polish will be taken into account.
- 4. Candidates who have obtained their certificate of secondary education from an **"old" matura exam taken in Poland up to 2004** have the opportunity to take the matura exam in the major subjects at the Regional Examinations Board (under Art. 44zzp of the Education System Act) and receive a letter of the results of the matura exam, based on which they will be admitted to university. Candidates who do not hold a letter from the Regional Examinations Board on the results of the matura exam in major subjects shall convert the grades of the major subjects taken during the matura exam according to the scale shown in Table 2:

- 5. Candidates with an **EB diploma** as referred to in Art. 2(1)(8), with results in the subjects applicable to a given field of study, will be admitted according to the following rules and subject to section 2:
 - 1) the result obtained in the EB diploma major subjects (as referred to in Table 1) will be taken into account;
 - 2) the result stated in the graduation certificate in the written part of major subjects, after being converted by the IRK system and multiplied by 10, constitutes a number of points in the application procedure (the result is converted using the rule according to which the result is rounded up when the value in the second decimal place is higher or equal to 5, and it is rounded down when the value is lower than 5).

Candidates who passed the EB exam in 2024 and did not receive their diploma by the required deadline shall provide a letter of the EB exam results (issued by the headmaster of the completed secondary school). The candidate shall submit a copy of the EB diploma (original available for inspection) as soon as it is received, but no later than 23 September 2024 (the date of receipt at the University counts). Failure to deliver the diploma by the deadline results in being removed from the list of students admitted to the university and the issuance of a decision on the refusal of admission due to failure to meet the application conditions (in the case of Polish citizens) or the termination of the Rector's conditional decision on admission to the university (in case of foreigners).

- 6. Candidates with an **IB diploma** as referred to in Art. 2(1)(8), with results in the major subjects applicable to a given field of study, will be admitted according to the following rules:
 - 1) the result obtained in the major subjects on the IB Diploma (as referred to in Table 1) will be taken into account, subject to the provision that the result from a subject taken at HL level is regarded as the result at the advanced level while the result from a subject taken at SL level is considered the result at the elementary level,
 - 2) major subject grades are converted into points in accordance with Table 3 and subject to section 2:

Candidates who have passed the IB exam in 2024 and did not receive their diploma by the required deadline shall provide a letter of the IB exam results (issued by the headmaster of the completed secondary school). The candidate shall submit a copy of the IB diploma (original available for inspection) as soon as it is received, but no later than 23 September

2024 (the date of receipt at the University counts). Failure to deliver the diploma by the deadline results in being removed from the list of students admitted to the university and the issuance of a decision on the refusal of admission due to failure to meet the application conditions (in the case of Polish citizens) or the termination of the Rector's conditional decision on admission to the university (in case of foreigners).

- 7. Candidates holding a **graduation certificate obtained abroad** (excluding the IB/EB diploma) shall convert their score in major subjects required in a given field of study according to the following rules:
 - scores expressed on a scale other than a 100 percent scale are converted according to Tables 4–11 developed for each country or grading scale:
 - 2) if there is no table corresponding to the grading scale used in the graduation certificate, a proportional conversion is applied (with rounding to integer numbers, according to the rule that it is rounded up if the value after the decimal point is greater than or equal to 5, , and it is rounded down if the value is lower than 5), assuming that the minimum passing grade corresponds to no less than 30 points or per cent in the application process.

Regarding Table 9: The result of the ZNO exam is considered an advanced-level score (on a scale of 200-0), which is converted using the following formula: 2 ZNO points correspond to 1 application point. In the event of cancellation of the ZNO exam by official educational authorities of Ukraine, points corresponding to the result stated in the graduation certificate or atestat are multiplied by 0.8 and rounded to an integer number.

Regarding Table 10: The result of the CT exam is considered an advanced-level score (on a scale of 100-0), which is converted using the following formula: 1 CT point corresponds to 1 application point.

3) the results stated in the graduation certificate, which cover a group of science subjects and include an area of knowledge and competencies from **all** major subjects required in a given field of study, shall be converted into points - as the result obtained from **each** of the required subjects. When converting the results covering a group of subjects, the rules provided in section 7 apply.

The AB may require the candidate to submit additional documents to validate the area, level of knowledge and learning outcomes in each major subject, particularly:

- a) a list of subjects and classes completed as part of the programme, along with grades earned;
- b) information concerning the completed curriculum, study period and grading scale;
- 4) In the case where there is no grade for **one** of the major subjects on the graduation certificate, then the score from that subject in the last year (class) when the subject was taught is taken into consideration. This score is converted into points by multiplying by a conversion factor of 0.8.
- 5) In cases not covered by this Annex, the AB shall make a binding interpretation and decide the case.
- 8. The University shall accept results obtained from the University Entrance Examination (Polish:

Uczelniany Egzamin Wstępny – UEW) taken at another university starting in 2022, provided that a positive result was achieved in **all** the required major subjects at the levels specified in Table 1. The results of the entrance examination will be recognised provided that the exams are conducted on the examination sheets prepared by the Central Examination Board and assessed according to the standards applicable when grading the matura exam sheets. The AB recognises the UEW results solely based on a letter issued on the letterhead paper, signed and stamped by the chairperson of the admission board for a given field of study, from the university where the UEW was taken.

Art. 5

Subject contest winners

The winners and finalists of the subject contests are admitted for the first year of studies in accordance with Resolution No. 1979 of the Senate of the Wroclaw Medical University of 19 December 2018 on the rules for admitting to the first year of studies at the Wroclaw Medical University of the winners/finalists/participants of national and international subject contests valid for academic years from 2019/2020 to 2026/2027.

Art. 6

Admission lists

- In the application process, the AB shall prepare and publish the Conditionally Accepted list, according to the total amount of points obtained by the candidates – from the highest to the lowest number of points.
- 2. The lists referred to in section 1 shall be created separately for each field of study, within the applicable admission limits.
- 3. Candidates are presented on the lists according to the candidate's ID number obtained from the IRK. The lists can be found on the University's website (admission page) and the notice boards at the Dean's office. The lists published on the University's website (admission page) are not binding they are provided solely for informational purposes. The binding documents are admission lists of candidates displayed on the notice boards at the Dean's offices of appropriate faculties.
- 4. Until the end of the application process, the candidates shall keep up to date with announcements and information concerning the application process, provided on the University's website and in the IRK, and they are responsible for the consequences and decisions resulting from failure to meet this obligation and for the decisions of the Board.
- 5. If several candidates obtain the lowest, equal amount of points entitling them to be admitted to the chosen field of study, an additional admission criterion shall be applied that is the score obtained in biology, followed by chemistry, physics, mathematics. Precedence is given to the candidate with the higher score in the aforementioned subjects. If, despite the use of the additional criterion, the number of candidates admitted to a faculty of medicine or faculty of dentistry exceeds the limit of places, a smaller number of candidates may be admitted to the first year of studies in these faculties.
- 6. Candidates:

- 1) admitted to higher education studies:
 - a) Polish citizens shall be accepted or conditionally accepted by the AB,
 - b) foreigners shall receive a Rector's decision or Rector's conditional decision on their admission to higher education studies.
- candidates who have not been admitted to higher education studies shall receive a decision on the refusal of admission to higher education studies.
- 7. Regarding the foreigners who have received a conditional decision on admission to higher education studies, the fulfilment of conditions specified in the conditional decision shall be confirmed by the chairperson of the AB with a signature and stamp under the phrase "I hereby confirm that the conditions of this Decision are met". At the candidate's request, the AB shall issue an attestation of the fulfilment of conditions provided in the conditional decision. Failure to fulfil at least one condition provided in the conditional decision within a specified period shall result in the Rector's decision on the refusal of admission to higher education studies.
- 8. Regarding the candidates with Polish citizenship who have been conditionally accepted, the fulfilment of conditions may be, at the candidate's request, confirmed by the chairperson of the AB by issuing an appropriate attestation.
- 9. Candidates who have been conditionally accepted to higher education studies are obliged to provide the AB with the documents listed in Art. 7.
- 10. The administrative procedure in the application process begins on the day of submitting an application form (the date of receipt) and other documents referred to in Art. 7 to the AB.
- 11. The documents listed in Art. 7 should be submitted and collected personally by the candidate or a person who holds the candidate's letter of authorisation, including a certification which validates the handwritten signature of the candidate, made by a notary or a member of the AB.
- 12. Discrepancies between the content of the documents submitted by the candidate and the data entered by the candidate in the IRK may result in the removal from the list of conditionally accepted candidates, as well as in a decision to refuse admission to the higher education studies due to a failure to meet the application conditions.
- 13. The candidates, upon admission, are obliged to pay the fee for educational services (tuition fee) on time. The amount and deadlines for payment of tuition fees are governed by separate regulations.
- 14. An underage candidate (a person who is under 18 years of age at the time of submitting a declaration of participation in the application procedure by registering in the IRK) may independently enrol in a degree programme on condition that they present a letter of consent issued by their legal representative allowing them to participate in the application process and to enrol in a degree programme, with a notarized signature. If the enrollment is made by a statutory representative, the presence of the candidate is not required.
- 15. Upon receiving a referral for medical examination by an occupational medicine physician as well as sanitary and epidemiological examinations, an admitted student is obliged to submit to the dean's office, within a specified period, a medical certificate stating that there are no contraindications to study. Failure to meet this obligation shall result in not being allowed to participate in classes. The list of harmful, arduous and hazardous to health factors is set out in Art. 13.

- 16. Failure to provide documents listed in Art. 7 within a specified period may result in the removal from the list of admitted students and a decision on the refusal of admission to higher education studies due to the candidate's failure to meet the application conditions. Other candidates shall be admitted to vacant places until the admission limit is met.
- 17. The withdrawal of documents before the end of the application procedure or failure to pay tuition fees leads to the issuance of a decision on the refusal of admission to higher education studies due to resignation from the studies.
- 18. Resignation from the application process for the university studies shall be submitted by a candidate:
 - 1) directly in the IRK, or
 - in electronic form by sending a signed resignation (a scanned letter with the candidate's signature) from the e-mail address registered in the IRK, or
 - 3) in person, or
 - 4) through an authorised representative.

Art. 7

Documents required in the application process

Candidates who have been accepted to higher education studies, including those who have been conditionally accepted, are obliged to:

- produce their identity document (original available for inspection); in the case when documents are provided by a person authorised by the candidate, an authorisation letter must be presented including a certification made by a notary or a member of the AB, which validates the handwritten signature of the candidate.
- 2. submit the following documents in a specified period:
 - 1) a hand-signed application form, printed from the IRK,
 - 2) the original of the graduation certificate referred to in Art. 2(1), together with the transcript of the grades; in the case of a graduation certificate obtained abroad the graduation certificate and the transcript of the grades may be delivered in the form of a notarised copy after the original graduation certificate has been legalised or provided with an apostille. The graduation certificate must be accompanied by a confirmation, issued by an authorised institution, stating that the foreign graduation certificate entitles the holder to apply for admission to any type of higher education in the country in which it was issued (in the absence of such an endorsement on the graduation certificate),
 - 3) a document certifying the knowledge of English referred to in Art. 4(1)(2) if required,
 - 4) a certificate of vaccination against hepatitis B,
 - 5) regarding underage candidates:
 - a) a declaration of the legal representative's consent to the candidate's participation in the application process and taking up studies, including notarization of the signature,
 - b) a copy (original available for inspection) of the underage candidate's birth certificate (in case of a parent), or a copy of a document confirming guardianship (in case of a legal guardian),

Documents must be translated into Polish by a sworn translator if they have been issued in a

foreign language.

Art. 8

Changes in the scoring system resulting from an appeal – supplementary application process

- The University provides for the possibility of conducting a supplementary application process for candidates who have applied for admission to the long-cycle Master's degree studies in a given field of study for the academic year for which the application procedure is conducted, and whose results of the matura exam in a given subject(s) was increased due to the verification of the sum of points or appeal against the verification of points to the Examination Arbitration Board (referred to in Art. 44zzz of the Education System Act).
- 2. In the supplementary application process, an application should be submitted to the competent AB for participation in the supplementary application process together with a document received from the Regional Examinations Board certifying the changed result of the matura exam, i.e. a new, changed certificate of secondary education or a new annex to the certificate of secondary education or a new annex to the certificate of secondary education or a new annex.
- 3. The start and end date for the supplementary application process are specified in the application schedule.

Art. 9

Appeals

- 1. The admission refusal is subject to:
 - 1) appeal, by the candidates with Polish citizenship, in writing to the Rector within 14 days from the date of delivery of the decision,
 - 2) request for reconsideration of the case, by foreign candidates, to the Rector within 14 days from the date of delivery of the decision,
- 2. In the case referred to in section 1:
 - 1) point 1, the appeal to the Rector must be submitted through the competent AB,
 - point 2, the request for reconsideration must be submitted to the Rector through the AB which conducts the admission procedure.
- 3. Within the time limit, the candidate may waive their right to:
 - appeal against the decision by means of a declaration submitted to the authority which issued the decision. As of the date of delivery of the declaration waiving the right to appeal, the decision shall become final and binding,
 - 2) apply for reconsideration of the case by means of a declaration submitted to the authority which issued the decision. As of the date of delivery of the declaration waiving the right to appeal, the decision becomes final and binding. Moreover, no complaint can be lodged to the Administrative Court with regard to such a decision.

Art. 10

Other requirements

1. Candidates for higher education studies are entitled to participate in the application procedure for

any number of fields and modes of study, subject to the provisions of sec. 2. In the case of applying for several fields of study at the same time, the candidate must pay an application fee for each field of study.

- 2. Those who are already students of a given field of study at the Wroclaw Medical University or another university cannot apply for enrolment in the same field of study.
- 3. Transfer of a student between universities or within a university, including a change in a mode of study, may occur only in accordance with the procedures provided in the study regulations. The decision on the transfer is made by the Dean.
- 4. In the event that candidates do not meet the admission limit for a given field of study, the chairperson of the competent AB, in consultation with the Head of the Admission and Graduate Career Path Monitoring Office and the Dean, shall decide on additional enrolment. Information on the dates applicable to the additional enrolment will be published on the University's website.
- 5. Foreigners shall be obliged to have health insurance coverage for the duration of their studies in Poland, either in the form of health and accident insurance, a European Health Insurance Card or insurance through the National Health Fund.
- 6. Information regarding the application process for the academic year 2024/2025 is available on the University's website and provided by the competent AB during the application period, as well as throughout the year at the Admission and Graduate Career Path Monitoring Office.
- 7. The University does not provide information concerning the results of the application procedure via phone.
- 8. Candidates with disabilities should communicate their specific needs to the Admission and Graduate Career Path Monitoring Office or the Office for Persons with Disabilities well in advance to allow the University to provide support at the desired time. Upon receipt of an application, the University will take action to overcome barriers to the application process for candidates with disabilities. The principles of support and coordination of activities for persons with special needs due to health conditions, including persons with disabilities, are defined in the Regulations for the support of persons with special needs of the Wroclaw Medical University.

Art. 11

Force majeure

The application conditions and procedure may change due to force majeure on the grounds and under the peremptory provisions.

Art. 12

Documents validating the knowledge of English
